#### WHAT'S IN THIS MAILING?

There are three forms in this packet that need to be completed as soon as possible.

The first is the Unit Data Form. It is due April 30, 2017 into Department. This is the information for the coming fiscal year of July 1, 2017 through June 30, 2018 and for the 2018 Membership (Calendar) year. We need to know how much your dues are for Senior and Junior members. We need to know where the members are to mail their dues and where Department is to mail checks for dues paid online through National.

The next form is your Unit Officers list. This is the list of members you elect in May for the coming year. This form is due into Department no later than June 1, 2017. If we don't have your list, you will not be able to pick up your membership cards at Convention.

#### MANDATORY DUES ARE DUE

If your Unit has not paid its Mandatory Dues, please get them in. If they are not received in Department by May 22, 2017, your Unit will not be able to vote at Convention.

The last form is your Delegates and Alternates form for Department Convention. Your Unit should select who will represent you at Convention and send that information on this form to Department. You need Delegates and you need Alternates who can fill in on the Convention floor when the Delegates need a break or if a Delegate can't come to Convention at the last minute.

For those of you who are new or those who need a refresher course: The number of Delegates a Unit is entitled to is based on its paid membership total 30 days before Convention. Let's say a Unit has 175 members.. If you look at the enclosed Certification form, the chart shows that Unit is entitled to 3 Delegates. That is equivalent to 3 votes.

This Unit would list and pay for 3 Delegates at \$10 each. So its voting strength is 3. The Unit will keep that strength even if only one delegate attends. But remember you must pay for all the Delegates to have your full voting strength

Your Unit should give direction to the Delegates and Alternates so they know how to vote since they are representing the entire Unit at Convention.

#### IF PURCHASING CARDS

- Purchase <u>GENERAL</u> Mother's Day Cards that say "Happy Mother's Day." <u>Do not</u> send cards that mention a relative, such as Mother, Grandmother, Aunt, Sister, etc.
- <u>DO NOT PUT THE POSTAGE ON THE ENVELOPES.</u> Send the stamps loose and we will put the postage on the cards when they are distributed to the residents.

#### **Emblem Significance**

(pg.6, American Legion Auxiliary Unit Handbook)



#### The rays of the sun

The rays of the sun form the background of our proud emblem and suggests the American Legion Auxiliary's principles of Loyalty, Justice, Freedom and Democracy will dispel the darkness of violence, strife and evil.



#### **Outer rings**

The larger of two outer rings stands for the rehabilitation of our sick and disabled veterans. The smaller inside ring denotes the welfare of America's children. The unbroken circle of blue represents Unity and Loyalty.



#### The star

The star, victory symbol of World War I and the emblem of service in war, no less the emblem of service in time of peace, also symbolizes honor, glory and constancy. The field of white behind the star exemplifies the hope of Freedom.



#### American Legion Auxiliary

The words American Legion Auxiliary tie the whole together for truth, remembrance, constancy, honor, service, veterans' affairs and rehabilitation, children and youth, loyalty, and Americanism.

#### **Emblem Usage**

The word "emblem" used hereafter shall mean insignia, badge, medal, emblem, or any colorable imitation thereof of the reproduction thereof, of the American Legion Auxiliary. The name and emblem of the American Legion Auxiliary are registered service marks in the U.S. Trademark Office (Original 1920 Patent No. 55398, renewed by Acts of Congress, Aug. 1935, June 1949, June 1962 and April 1976) and are protected by criminal and civil enforcement provisions of federal law. The official emblem of the American Legion Auxiliary is on file at National Emblem Sales, The American Legion National Headquarters, Indianapolis, Ind. (<a href="https://emblem.legion.org/">http://emblem.legion.org/</a>).

The National Organization may grant permission to use the name and emblem in accordance with that resolution, other resolutions and U.S. Trademark law. The national officers are charged with resisting and restraining any unauthorized use of the name "American Legion Auxiliary" or the emblem.

A resolution, passed January 13, 1948, states that the manufacture, sale, or purchase for resale, either separately or appended to, or to be appended to, or the reproduction on any article of merchandise manufactured or sold, of the badge, medal, emblem, or other insignia or any colorable imitation thereof, of the reproduction thereof for commercial purposes of the American Legion Auxiliary, or the printing, lithographing, engraving, or other like reproduction of such badge, medal, emblem, or other insignia or colorable imitation thereof the American Legion Auxiliary shall be in accordance with the rules and regulations declaring the policy of the American Legion Auxiliary.

The use of the emblem by the individual unit member shall be limited to the wearing of the official insignia and to the possessions of authorized jewelry or merchandise bearing the emblem, using the imprint of the emblem upon stationary and official supplies, upon unit publications, and to the use of authorized regalia or merchandise bearing the emblem.

The use of the emblem by departments shall be the same as by use of units, except that convention committees in several departments are privileged to use the emblem for decoration and souvenir purposes, subject in each instance to the approval of the national secretary.

Any other use of the name "American Legion Auxiliary" or the emblem shall be subject to the approval of the national secretary, provided, however, (a) that any requests for such other use of the emblem by units shall first be subject to department approval before submission to the national secretary, and (b) that any other such use by the departments, when approved by the national secretary, shall be confined within the territorial limits of the department.

No unit, county, district, state or other department of the American Legion Auxiliary, and no officer or member thereof, has authority to grant the right to manufacture, reproduce or deal in items bearing the name and/or emblem of the American Legion Auxiliary.

Use of the American Legion Auxiliary Emblem is controlled by the National Headquarters. All requests for approval to use the emblem must first be sent to the department secretary. The request letter must state who will perform the duplicating (manufacturer), the name of the product, its intended use and the exact amount being ordered. Products must be of U.S. manufacture. Additional quantities require new authority. The department secretary indicates her approval and affixes her signature before forwarding the request to the national secretary.

The letter authorizing use of the emblem by the national secretary must be issued to the manufacturer and will be sent directly to the manufacturer. Copies of the authorization letter will be sent to the department secretary and the person making the request if that information has been provided. Any other use of the name "American Legion Auxiliary" or the emblem shall be subject to the approval of National Headquarters. These restrictions apply equally to the emblems of The American Legion and the Sons of The American Legion.

#### **Emblem Use on Grave Markers**

Purchases of grave markers from National Emblem Sales do not require approval of the national secretary. The use of the American Legion Auxiliary emblem on grave markers purchased from outside sources requires approval from both the department secretary and the national secretary. All requests must first be sent to the department secretary. After approval there, it will be forwarded to the national secretary for consideration.

For a deceased member the following information is required:

- Full name and address of the member.
- Name and number of the unit to which she belonged.
- Verification that she was a member in good standing at the time of death.
- Name and address of the manufacturer of the grave marker. If the manufacturer is unknown, the name and address of interment must be sent.

To receive approval for the use of the American Legion Auxiliary Emblem on a grave marker on a pre-need basis, one of two conditions must be met:

- 1. She must have been a member of the American Legion Auxiliary for at least twenty (20) consecutive years, or
- 2. She must be a VIM (paid-up-for-life) member, regardless of the length of her consecutive membership.

If the member is deceased and the request is made by her family, the member must have been a paid-up member at the time of her death.


#### **Emblem in Print & Online**

Use of the emblem in print and online is governed by National Headquarters. The use of the emblem in the electronic medium does not constitute permission to reproduce it. Permission to reproduce the emblem is confined to those activities listed in "Emblem Usage." If a local unit, post, or department wishes to use the emblem on a newly designed graphic, a letter of request for approval must be sent to the national secretary.

Units are confined to using the emblem or reproduction of the emblem on stationary, unit publications, notices, posters, place cards, or matters of similar character used in the ordinary routine and conduct of legitimate unit business. Departments are similarly limited. Any other use of the name "American Legion Auxiliary" or the emblem shall be subject to the approval of the national secretary.

#### **Emblem Specifications**

Each emblem consists of an accurate reproduction of the patented American Legion Auxiliary Emblem in four colors- gold, dark gold, Reflex blue and white. The emblem must be displayed on a background of a diameter slightly larger than the emblem. No other objects or lines shall be directly imposed upon the emblem. The American Legion Auxiliary Emblem may be used in different color variations, including a **4 color process**, a **3 color process**, grayscale, and black & white (see below). The primary and most preferable is the 4 color process. The second most common is the black & white.



#### Logotype and Font

Trajan Pro is the preferred font for "American Legion Auxiliary."



This type treatment in conjunction with the emblem is called a **logotype**. A common treatment (*above*) is a stacked vertical treatment or a color bar placed with the emblem. The emblem may also be placed on top of **complex graphics and photography**, as in the example (*below*).



Please observe **Flag Code** when using the flag in print. Note the left position of the American Flag in relation to the American Legion Auxiliary flag (*below*). In addition, note that the flag poles are not in any way disrupting the shape of the emblem.

#### Year-End Reports

Each department Education chairman is required to submit a narrative report by May 15, 2017, to the division Education chairman at her address found on the front page of this program Plan, and copy the national Education chairman. Members and units should follow their department's protocol and deadlines.

## As part of your Narrative Report, please include answers to the following questions:

- Did member/units participate in Teacher Appreciation Week? How?
- How was Give 10 participation recognized in your department?
- Describe how Veterans in Community Schools programs were presented?
- If units actively support veteran's associations on campus, describe their activities?
- What types of help did units give a needy student?
- How did units/department recognize scholarship winners?
- How many scholarship applications were received for national scholarships?

This is my last Unit Mailing. Please remember to report everything you have accomplished this year for Education.

#### Leadership

Have you ever thought of April as a month of "New Beginnings"? This is no April Fool's joke. It really is a time of new beginnings in the American Legion Auxiliary for Leadership.

New Beginning #1 – Reporting – Our Auxiliary year of reporting runs from April 1st of one year through March 31st of the following year. This is the time of year to start your new Department of Michigan Annual Tracking Form for Reporting. This form is an excellent tool to make your annual reporting more efficient. If you attended a Leadership Workshop during this past year, you received a copy of the form in your packet of handouts. If you did not attend a Workshop, you can find this form on the Department website (<a href="www.michalaux.org/resources/forms">www.michalaux.org/resources/forms</a>). Whether you give each member a copy to record their own activities, keep a notebook at the Post for members to record their own activities, or you delegate someone to record hours reported at each meeting, please consider using this tool so that more of the good things your Unit does for our Veterans and our communities get recorded. Also, remember to write a short narrative after a special event or project so that it will be ready for you next March when you do your annual reporting.

New Beginning #2 – Leaders – Many Units will be electing their officers for the next Auxiliary year in April. Each Unit should try to elect a <u>team</u> of leaders that will focus on the mission of the American Legion Auxiliary. Do your officers promote the programs of the Auxiliary? Do your projects help our Veterans, our active military and their families, our children and youth, and our communities? Are your officers willing to work with the Legion Family of your Post to carry out our Missions? Do your officers promote the American Legion Family in your community in a way that will attract new members? Do your officers understand the value and expectations of participating in meetings and activities beyond the Unit level? The officers you elect each year are key to making this type of leadership happen.

New Beginning #3 – Department Convention – Look ahead to June and Convention. While it is true that our Department Convention is the culmination of the Department Auxiliary year, work, and events, will this be a new beginning for your Unit? Does your Unit already send Delegates to the Department Convention? If not, why not make this the year that your Unit starts becoming involved at Department Convention. Not only are reports given and award winners announced, but changes to our governing documents take place at this time. New

Department Officers are elected for the following year. If your Unit would like to have a say in these things, you must send a Delegate(s) from your Unit to participate. No Delegate from your Unit means your Unit has no representation – your voice cannot be heard. Last year at Department Convention, our membership totals allowed for 516 Delegates and a possible 97 Delegates-at-Large giving a total voting strength of 613. (Delegates-at-Large are the current officers, District Presidents, members of Department Standing Committees, Past Department Presidents, VA Representatives for the hospitals and homes and their 1st Deputies.) Of the possible 613 votes allowed, the total voting strength registered was 194. In other words, less than 1 out of every 3 potential votes was cast. Less than 1 out of every 3 voices were heard on matters that affect every member within the Department of Michigan. Watch for more information on choosing your Delegates for Department Convention in the May Unit Mailing.

As we wrap things up for the 2016-2017 year, let's think about the "New Beginnings" we can make for our next Auxiliary year.

As we continue to "keep our promise" by fulfilling the mission of the American Legion Auxiliary, we must look forward to the fulfillment of our Centennial Strategic Plan to lead us into the future. Our Past Presidents Parley program is a perfect way to accomplish this.

The word "parley" comes from the French word "parler" which means to talk. Parleys provide means for creative thinkers and leaders to come together to talk, discuss and deliberate about how to raise awareness and propose solutions or compromises to strengthen and grow their units and departments. They can be an opportunity to develop meaningful strategies to accomplish goal 4 of the Centennial Strategic Plan, i.e. to develop leadership at all levels.
