Member Award: 10 X 10

· Award: \$100

Presented to: Members that recruit 10 (ten) NEW junior and/or senior members for the 2020 membership year by November 10, 2019. Ten by the 10th - the ALA's 100th birthday!

• Deadline: Members must be entered in ALAMIS system by 11/10/19.

FORMS must be received at National HQ by November 15, 2019.

Drawing: All verified entries will be placed in a drawing for \$1000 towards a trip to the ALA 2020
 National Convention plus two States Dinner tickets (there will be one winner)

Note: If winner of the drawing does not attend National Convention, reimbursement will be required. There will not be a second drawing/alternate winner.

Member Award: R/R5 - Recruit/Rejoin 5

No additional action or form required. Note: You can enter for both deadlines, but if you got the award for the first deadline, to be eligible for the second deadline, you will need to recruit/rejoin 5 additional members by June 14th (can't be same people from the 10x10 or Feb. 17th deadline)

Unit Award: 100% Unit Award

- Award: 100 awards of \$100 to be used to advance the ALA mission
- Presented to: Units that reach 100% of their 2020 membership goal by November 10, 2019 will be placed into a random drawing from which 100 units will be selected to receive \$100.
- Deadline: American Legion Auxiliary birthday, November 10, 2019

· Materials and guidelines:

 This award will be based on units that reach 100% of their reported goals by November 10, 2019 as verified by ALAMIS

Note: Departments must submit Unit goals to National Headquarters by September 1, 2019 to be eligible for the 100% Unit award and all Department awards. These must be sent in a specific format which will be provided by NHQ.

DEPARTMENT AWARDS

Per Nicole's "ALA's 100th birthday wish," Dept awards will be based on assigned Dept Goals which will be one (1) new member per number of Units in the Department over last year's membership numbers as of 30 days prior to the 2019 National Convention – July 27th 2019. A department's unit count will be the number in the ALAMIS system as of July 27th. This will include any units that haven't yet been cancelled at the 2019 National Convention. (i.e.: if you are submitting 7 units for cancellation during convention, those 7 units will still be part of your unit count for determining your dept membership goal.)

Department Award: Pearl Harbor Day Award

- Presented to: Departments reaching 75% of their 2020 Department membership goal
- Deadline: December 7, 2019
- Materials and guidelines:

Department Award: Armed Forces Day Award

- Award: \$250 to be used to advance the ALA mission
- Presented to: Departments reaching 95% of their 2020 Department membership goal
- Deadline: May 18, 2020
- Materials and guidelines:
 - o Award will be based on membership entered in the ALAMIS system by May 18, 2020

**NOTE: Depts that receive the Pearl Harbor Day Award are also eligible for the Armed Forces Day Award.

Department Award: The Celebration Award

- · Award: \$500 to be used to advance the ALA mission
- · Presented to: Any Department that has reached the Department Goal
- Deadline: 30 days prior to the 2020 National Convention Aug. 1st, 2020
- Materials and guidelines:
 - o Award will be based on membership entered in the ALAMIS system by Aug. 1, 2020
 - Winners to be announced at National Convention 2020.

**NOTE: Depts that receive either or both the Pearl Harbor Day and the Armed Forces Day Awards are also eligible for the Celebration Award

The National Membership Chairman will inform any department that has award winners except for The Celebration Award. It will be announced during Membership remarks at National Convention.

10 x 10 = 100 Years of ALA history to celebrate on ALA's 100th!!

- Please fill out ALL of the lines on the form completely & ACCURATELY (spelling & legibility of names is vital).
- Please do not submit this form with less than 10 new members. Only one of each gift per award period per person.
- Due to the volume of forms we get right before the deadlines, incomplete forms (WITH LESS THAN 10 NAMES) and those with misspelled/illegible names that cannot be verified in ALAMIS may not be processed and time constraints will likely prevent department or national staff from informing about the need for or requesting corrected information.
- DEPARTMENT SECRETARIES MUST VERIFY & SIGN ALL OF THE FORMS. Allow ample time to get them
 to the Dept Secretary before each deadline. NEITHER NATIONAL NOR DEPT'S WILL ACCEPT FORMS
 AFTER THE DEADLINE. <u>Dept Secretaries</u>: <u>Please do NOT snail mail forms after you've already</u>
 scanned or faxed them to National. We just need them once!
- It is extremely helpful to the staff at National HQ if these forms are transmitted as frequently as possible (i.e. as a member gets their 10th recruit or as soon as the department receives the form). Please do not hold them to submit all at one time near the deadline. National literally get hundreds at once and it would be greatly appreciated if we could process them earlier.
- All members (recruiters) who submit the 10 x 10 Award entry form are automatically qualify to receive
 the first R/R 5 award. There is no additional action or form required for them to get that. If a member
 goes on to recruit/rejoin more members beyond the 10 on this award, they can start keeping track of &
 submit those additional people on one additional R/R 5 Award form for the June 14th deadline.
- Multiple forms (from several members) can all be mailed to the Dept in one envelope saving postage costs. Or, better yet, most departments happily accept scanned/emailed forms...or faxes if they have it.
- Some sort of award will be offered each year....the annually updated forms are housed in the
 "Member's Only" area of the ALA website on the "Membership Committee" page or you can request
 them from your department. Each year is a clean slate so members can earn them every year!
- The "Recruit or Rejoin 1" and "Recruit 10" awards from previous years have been discontinued and are invalid.
- TAL /SAL members can earn this award for recruiting/rejoining ALA members, too. Share this with your Legion family.

Additional Membership Incentive for the ALA's 100th Year

"One Week of Caring & Sharing for the Next Century of the ALA"

For one week this spring, April 1-7, 2020, we are asking Units members and leaders to work together to contact all members of their Unit. We want you to *call* (or visit) members in good standing, members who still need to renew, and former members that need to rejoin (have not paid dues since 2017). The purpose of these calls is to let ladies know their membership is valued and/or they are missed.

- Award: 100 unit awards of \$25 to be used to advance the ALA mission
- Presented to: Units that fulfill the intent of the incentive during the week of April 1-7, 2020, and meet the criteria outlined on the award certification form, will be placed into a random drawing from which 100 units will be selected to receive \$25.
- Deadline: Certification form must reach National HQ by midnight on Friday, April 30, 2020, with the required rejoin processed in ALAMIS by Friday, April 24, 2020 four business days prior to form being due to National to give time for Departments to process the rejoin and get form forwarded to National by April 30.
- · Materials and guidelines:
 - This award will be based on units that organize a unit-wide/inclusive event to reach all unit members (past and present) to reinforce their value to the unit and its mission.
 - O How to Sheets, scripts for use during the event, and an optional award certification form are included in this supplement (and on the ALA Membership Committee page on the national website). Our sincerest hope is that every unit commits to some sort of effort during this week to make sure their members know how important they are whether or not the unit meets the criteria to or chooses to fill out the form to be placed in the drawing.

Membership Reporting:

Mid-Year Reports

Mid-Year reports reflect the program work of units in the department and are intended as an opportunity for mid-year correction. Each department Membership chairman is required to submit a narrative report by **January 5, 2020** to the division Membership chairman, plus copy the national Membership chairman.

Year-End Reports

Annual reports reflect the program work of units in the department and may result in a national award for participants if award requirements are met. Each department Membership chairman is required to submit a narrative report by May 15, 2020 to the division Membership chairman, plus copy the national Membership chairman. Members and units should follow their department's protocol and deadlines for report submissions at the department level, as they may require earlier submission or review of them.

NOTE: The National Chairman will use the information and pictures that department chairmen share to craft their platform speech, as well as create their annual report that goes in the convention guide. It is important that clear, properly formatted emailed photos are sent in with both the mid-year & annual department reports so these can be considered for use at end of year.

Seating at National Convention:

Seating at the 2020 National Convention will be based on best overall membership performance as determined by a department's percentage to National President Nicole's "100th Birthday Wish" department goals as of 30 days prior to the 2020 National Convention (August 1, 2020). Departments will be sorted by best overall membership performance starting with the top ten (10) with the highest percentage to goal being seated at the front. All other departments will be seated based on overall membership performance according to rank.

*No category groupings or reports this year.

Renewal Notice Schedule:

The first renewal notice will be mailed by September 15, 2019, for the upcoming membership year. A second notice is mailed by January 15, 2020, for the current membership year to members who have not paid dues by the beginning of December 2019. Units are encouraged to supplement the national renewal notices with unit generated renewal notices and personal phone calls. The ALA membership year is from January 1 to December 31.

Special 100th Anniversary History Program Facts:

Membership has been a focus since the ALA's inception. Within the first year, 1,342 units had been organized. By the first convention in 1921, forty-two states had chartered Departments (with Minnesota being the first) as well as the territory of Hawaii. The first ALA National Membership Chairman was Lillian M. Towne from the Department of Maine, in 1924. Membership saw steady growth until the great depression. However, shortly after the depression ended, membership again grew each year. By 1950, the ALA reached 975,000 members. Granddaughters did not become eligible until 1970. History shows us that each time the ALA served our active military or veterans 'hands on' our membership grew.
